

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

OPEN ONLY TO LEGAL UNITED STATES RESIDENTS RESIDING WITHIN A SEVENTY-FIVE (75) MILE RADIUS FROM CARSON, CA, AND WHO ARE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. INTERNET ACCESS REQUIRED.

- Promotion Period:** The Welch's® Fruit Snacks LA Galaxy Sweepstakes (the "**Promotion**") begins July 1, 2019 at 12:00 a.m. Pacific Daylight Time ("**PDT**"), and ends on August 30, 2019 at 11:59 p.m. PDT (the "**Promotion Period**").
- Eligibility:** Open to legal United States residents, residing within a seventy five (75) mile radius from Carson, CA (the "**Territory**"), and who are 18 years of age or older as of date of entry. There is no retail value associated with the VIP experience.

Sponsor reserves the right to cancel, terminate or modify the Promotion if it cannot be completed as planned for any reason, including infection by computer virus, bugs, tampering, unauthorized intervention, technical failures or corruption of any sort.
